#### **ERICA SLAUGHTER - ACCOUNTING**

- Erica has a new job title Director of the Office of Finance & Accounting. (Congratulations to her!) Sally Frappe will cover Erica's prior responsibilities.
- Anna McCullen is leaving, Kathy Bencivengo will serve as interim until the new CFO is on board on December 20, 2021.
- An email will be sent when WLL funding is able to be drawn.
- Close out reports will be required when funding ends
- Certification letters are to be attached to your SAGE draw vouchers addressed to Erica Slaughter, Director of the Office of Finance & Accounting.
- DHS closeout date is 12/31/21 so all SFY21 WFNJ funds should be drawn by then. It is difficult to get them o open the account after December 31st.
- WIOA reporting the June 2022 PY 20 accruals will be reported as drawn and disbursed on a final July 2022 report

# EMILY WATTS – INTERNAL AUDIT Updates:

- Monitoring will be remote for state fiscal year 2022 (SFY2022)
- Each SAGE payment voucher (aka cash draws) must have an uploaded miscellaneous attachment. The attachment should be either a spreadsheet or accounting system run that totals the requested drawdown amount. On a quarterly or semi-annual basis OIA will request two or three invoice samples from the payment voucher support documentation. Cash Drawdown support reviews will be conducted independently of fiscal monitoring.
- For 2021 Any fees or charges paid to a consultant who provides services under WIOA shall be limited to a cap of \$750 per day, or \$93.75 per hour (representing an eight-hour work day). <a href="https://www.dol.gov/agencies/eta/grants/resources">https://www.dol.gov/agencies/eta/grants/resources</a>

#### Important Reminders:

- To use "Stand in costs" to pay for questioned costs they must be:
  - Reported as Stand in costs in the LAR under the stand in costs column as it is incurred.
  - Reported in the month that the guestioned cost occurred.
  - Recorded in the accounting system and paid for with other non-WIOA/WFNJ grants and allowable costs
  - o Cannot be "in-kind" or donations

Note: Stand in costs are zeroed out at the end of each year on July 1 each year. They do not roll over despite WIOAs two-year grant year.

- Equipment and software items over \$5,000 each must be necessary and reasonable for the performance of the award and have prior written approval from:
  - Assistant Commissioner of Workforce Development Hugh Bailey Always copy: Director of Workforce Development - Yolanda Allen, Executive Assistant – Denise Givens, (DOL)

- The new OIA survey will start asking if the WDB has an annual monitoring program and monitoring reports of the One-Stop. OIA will start requesting copies of these to review at a later time.
