Welcome and Introductions

## ACCOUNTING - Erica Slaughter

- The delay in drawdowns were due to employee shortages which required staff task changes.
- Staff to contact for drawdowns for Atlantic County through Mercer (alphabetically) is Cailyn McGee and copy Sally Trappe.
- Staff to contact for drawdowns for Middlesex through Union (alphabetically) is Madella George and copy Sally Trappe.
- WFNJ drawdowns Gloucester through Union needs to put TANF Work Activities and Case Management on a separate draw.

- May be scheduling audits well in advance for required 12-month plan for USDOL.
- Cheryl Fuller, Fiscal Director for Hudson County will be helping with auditing.
- Fallback entity that USDOL expects to return the funds for questioned costs is for the county in question not the state.
- Remember to attach reporting backup and stand-in costs to reports.
- Recommend that Fiscal creates a rule that if haven't submitted a full report for 2-3 months, cash draws will be on hold till reports are reported up to date.

- Local area contracts PY22 / FY23 not started yet. PY20 and PY21 are getting approved.
- WFNJ NOA 50% obligation requirement by 12/31/22 will be reviewed with program staff and will also review WLL restrictions.

- USDOL OIG is visiting Newark & Hudson since May 2022. USDOL ETA not expected to come back until next summer 2023.
- WLL funding additional funds? Special revenue fund of the percent of revenue goes to WDB's. Currently diverting funds to another project. Will let you know if any funds become available.
