Welcome and Introductions

Kevin Kurdziel called the virtual meeting to order at 10:03AM and welcomed the membership to the February meeting.

Attendance was taken via the chat feature of Zoom by Monica Mulligan.

Correspondence

Monica Mulligan reported that there was no correspondence.

Approval of the January 12, 2022 Minutes

The minutes of the January 12th GSETA meeting were presented by Monica Mulligan.

Yolanda Taylor indicated that her last name was misrepresented as "Allen" in the correspondence section of the January minutes. Monica Mulligan indicated that change would be made.

Paul Grzella made a motion approve the January minutes with the one correction. Diane Seavers seconded the motion. There were no objections or abstentions. The motion was approved.

<u>Treasurer's Report – January</u>

Leslie Williams presented the January Treasurer's Report (attached). She indicated that the bank reconciliations and bank statements and have been provided to the Executive Committee. Leslie reported that the A/R report was run as of January 31, 2022, as well as February 8, 2022, so the Aging Report is up to date as of yesterday. She asked that everyone check this report and if their local area is listed to please follow up on making payment. Leslie indicated that the net revenue from the GSETA conference was \$79,392. All conference related invoices have been paid. Leslie indicated that invoices for the GSETA institute will be going out tomorrow, 2/10/22.

Paul Grzella made a motion approve the January Treasurer's Reports as presented. Fran Kuhn seconded the motion. There were no objections or abstentions. The motion was approved.

President's Report

Kevin Kurdziel indicated that February was Black History Month and provided membership with information on the origins of this celebration. He indicated that perhaps next year GSETA would be interested in doing a special event to commemorate Black History Month.

Kevin indicated that Hugh Bailey would be speaking shortly about OJT and reminded membership that training for the new OJT funds would be managed through the GSETA institute in concert with state contracted vendor EDSI.

Kevin informed the group that GSETA has a new tagline created by Larry Sternbach: "Strategic Impact, Operational Excellence".

Kevin reminded membership that the Executive Committee would be meeting with Commissioner Asaro-Angelo on Thursday. The Executive Committee hopes to hear about the NJDOL's priorities so that GSETSA can be sure to align its priorities with that plan.

Kevin ended his report by letting the group know that he continues to do research into what other state organizations like GSETA are doing, especially considering WIOA re-authorization being on the horizon.

Update OJT NOA

Assistant Commissioner Hugh Bailey introduced himself and let membership know that he appreciates the commitment and passion the local areas have shown in their work. Hugh talked about the OJT model this envisioned with the funds that have been allocated to each area – to refer and market OJT to career seekers so that they can connect with employers around this hiring incentive. These OJT funds can subsidize training for up to 6 months with employers being reimbursed for their training costs. Hugh indicates that OJT has been shown to be effective. While OJT funds have historically come down through the state to the BSRs, this model will be a new way of engaging businesses. The current OJT funds have been granted through Dislocated Worker funds. It is anticipated that each local area will receive a new allocation for Program Year 2022. Hugh indicated that training on the use of these OJT funds by EDSI through the GSETA institute will be happening in March. Hugh acknowledged that the use of OJT has been somewhat disjointed, but that NJDOL is looking to streamline the use of these funds. He also indicated that he knows that local areas will likely not expend their PY21 OJT allocation based on when they were given to the local areas.

Beth Rodgers inquired about the \$10,000.00 cap on OJT. Hugh Bailey indicated that is a local area wants to work with an employer for more than 6 months, they can make the case for an exception to this rule.

Howard Weiss and Jeff Swarts both expressed concerns about employers not getting reimbursed when they have used OJT through state BSRs. Hugh indicated that there has been some holdups with paying employers through the "Return and Earn" program, as they were funded by ARP funds that have not been released to the state yet. Hugh indicated that all employers will be paid by the end of March.

Fran Kuhn asked if the percentage of reimbursement could be moved from 50% to 70% based on local WDB policy. Hugh indicated the WDBs have latitude and NJDOL will be working on making clear when this latitude is applicable and acceptable.

Pat Leahy asked if OJT can be utilized to offset staff costs. Hugh indicated that the state needs to give more support and technical assistance on how local areas can maximize programmatic priorities. These funds can be used for staffing, but they must be used by staff who are directly touching businesses. There are no admin costs with these funds.

Strategic Plan

Kevin Kurdziel indicated that GSETA's strategic plan will focus on two pillars: Strategic Impact as well as Operational Excellence in keeping in alignment with GSETA's new tagline. The plan should be actionable and concise. There will be four committees created to align with these two pillars and each committee will develop 3 -4 goals:

- 1. Advocacy, Communication and Marketing
- 2. Resource Development
- 3. Membership and Programs
- 4. Professional Development Kevin asked the membership to stay tuned for an email from Monica Mulligan asking for volunteers for each committee.

Victoria Bollhardt and Paul Grzella both expressed concerns about creating additional spaces for meetings when there may be duplication with what already exists. Perhaps meetings can be combined.

Virgen Velez indicated that most of the duplication seems to exist not on the subcommittee level but between GSETA Membership meeting, WDB Directors' Meeting and State Directors' Meetings. Better coordination needs to occur here to encourage continued participation. There should be active engagement of both the operations side as well as the strategic side.

Virtual Conference

Kevin Kurdziel indicated that the 2022 conference will be held virtually. Allison Spinelli will Chair but needs a Co-Chair. Larry is unable to take on this responsibility as his office is in the process of moving from Eatontown to Neptune. Please let Kevin know if you are interested in taking on this Co-chair role. Kevin indicated the committee will be looking to choose a date (late September or mid-October), choose a theme (perhaps around the 2 pillars), select vendors (such as Motown Digital), come up with a marketing plan to get the conference info out as well as a plan to sell sponsorships.

Committee Updates:

Executive Committee - Kevin Kurdziel reported that this committee is meeting monthly on the Wednesday before each full GSETA membership meeting. It has been focused on the strategic plan and will now be handing this off to committees.

Monitoring Committee – Yolanda Taylor reported that the committee meets quarterly and last met in January. Leslie Hirsch gave a presentation on the ETPL. Sarah Singer Quast and Pat Robertson provided information on monitoring as well as provided some tools to the group. The next meeting is scheduled for April 21, 2022.

MIS Committee – Diane Seavers indicated that this committee meets monthly. The January meeting has a presentation by Justin Ryan and Lydia Crockett from Futureworks. They gave a demo of the new website and reporting features. They would like to do in-person training and are looking for a local area to host. There would be a need for 10 - 12 computers available. Futureworks also has a demos and training available on its website and can conduct training virtually as well. Diane indicated that while there has been talk of a new system to replace AOSOS over a year ago, she has not received any information or update on where this stands.

Jeff Swarts indicated that NJDOL was selected by USDOL to be a pilot to upgrade the UI system. There are several other states that were also selected to participate.

Operations Committee - Fran Kuhn reported that the committee meets monthly and last met of met on February 7, 2022. He indicated that the committee discussed that up to 30% of WFNJ funds can be used to market voluntary SNAP participation. He indicated that NJDOL is working on something similar for TANF.

Professional Development: Fran Kuhn reported that the GSETA Institute will be sending out more information on the registration for Wellness Wednesdays. There will also be training scheduled on software programs such as Excel. The group is also looking info more long-term certification programs for career counselors.

Youth Committee: Kendra Lee reported that the group met earlier this week. They discussed OJT, laptop loaner programs and incentives. She also asked which local areas applied for SYEP. Six local areas raised hands. Virgen Velez indicated that NJDOL is encouraging local areas to be innovative and creative by using TANF funds for summer youth programming. There was some concern expressed about STEP because it tends to be focused on those that don't really need the support in the same way WIOA youth need. There was also concern that these programs tends to be focused on those in urban centers at the exclusive of those that live in more remote areas of counties. Paul Grzella indicated that feedback received has been positive because the funds allow for more flexibility.

Fiscal Committee: The next meeting will be held on March 21, 2022 at 10AM.

Open Discussion

Kevin Kurdziel indicated that WIOA re-authorization is back on the table and that he is working with Chris Anderson as well as other state organizations from around the country to make sure we are aware of all that is taking place at the federal level. Kevin indicated that there is some discussion about simplifying the IFA process.

Adjournment:

Jeff Swarts made the motion to adjourn the meeting. Paul Grzella seconded it. There were no objections or abstentions. The motion was approved. The meeting was adjourned at 11:51AM.

The next GSETA meeting is scheduled for March 9, 2022 at 10:00AM via Zoom.
