GSETA Fiscal Committee Meeting March 21, 2022 Zoom

A zoom meeting of the GSETA Fiscal Committee was held at 10am on March 21, 2022. The attached list is those who signed in on the chat.

Welcome and Introductions

INTERNAL AUDIT – Terry Vallely

- In process of the PY21 local area reviews begin all by 6/30/22.
- Inundated with a lot of external audits (UI and other federal funding)
- Paul Warsaw will be out for a bit so his 4 counties will be reassigned.
- Will be reviewing the documents attached to draw vouchers.
- Quarter-end reports timeliness is critical. We have gotten comments from recent meetings with Feds.
- Office of Inspector General will review 2018-2021 and will include 2 local areas to review training providers related to PPE and whether or not they continued to provide training during the pandemic. Report goes to ETA, not NJDOL (WIOA and other ETA grants). Goal is to build an audit program they can use to procure a company to complete this review nationally.
- WDB requirement for oversight of the One Stop fiscal and program work. USDOL,
 Yolanda and team are working on requirements and possible template.

FISCAL QUESTIONS & DISCUSSION - Committee

- PY20 Local area contracts should be completed. PY21 contract information not yet in SAGE.
- SYEP NOA split WFNJ & WIOA on a separate contract not in SAGE. With monthly
 reports Erica is going to follow up Patricia Jordan to have a conversation and will try to
 get some guidance on how we need to report expenditures. The funding on the NOA
 does not impact the youth I=eligibility listed in the grant notice.
- OJT funds can be used for government employees allowable if eligible but need more information about how to issue the contract (cannot issue contract to your own entity).

ACCOUNTING - Erica Slaughter

- Closeout for WIOA PY21 in SAGE is the 25th month (July 15, 2022 reports) No payables and all draws should be completed.
- Will need to talk to the programmers to see if we can extend the due date.
- There is no option to go back and change the report in SAGE after it is filed system will automatically generate a funding-reducing NOA for any remaining balances.
- FIFO to try and charge back and spend funds that are ending.
- No extensions due to COVID for formula funds.
- NJDOL will be sing letters about funding that needs to be returned.
- Rent invoices for July-December 2022 will go out in the next week. These will be submitted 6 months at a time.
