Welcome and Introductions

Kevin Kurdziel called the virtual meeting to order at 10:04AM and welcomed the membership to the March meeting.

Attendance was taken via the chat feature of Zoom by Monica Mulligan.

Correspondence

Monica Mulligan reported that there was no correspondence.

Approval of the February 9, 2022 Minutes

The minutes of the February 9, 2022 GSETA meeting were presented by Monica Mulligan.

Virgen Velez made a motion approve the February minutes as presented. Leslie Williams seconded the motion. There were no objections or abstentions. The motion was approved.

Treasurer's Report – January

Leslie Williams presented the January Treasurer's Report (attached). She indicated that the bank reconciliations and bank statements and have been provided to the Executive Committee. Leslie reported that there are two A/R aging reports run as of February 28, 2022, as well through March 8, 2022. She asked that everyone check this report and if their local area is listed and they have questions, to reach out to her. Leslie indicated that all checks had been deposited.

Leslie indicated that all correspondence related to POs/billing should be sent to her email at leslie@ccwib.com. Kevin Kurdziel asked that Monica Mulligan send this out to membership so that there is no confusion on where POs and other information should be sent.

Allison Spinelli made a motion approve the February Treasurer's Reports as presented. Terri Bryan seconded the motion. There were no objections or abstentions. The motion was approved.

President's Report

Kevin Kurdziel indicated that February was Women's History Month and provided membership with information on the origins of this celebration and the importance of women in our workforce system. Kevin noted that GSETA has a strong record of having women in leadership positions. Kevin also asked membership to keep those in Ukraine in their thoughts.

Kevin updated the group on the OJT/Work Based Learning training being presented by NJDOL contracted provider EDSI through the GSETA Institute. The content of the training is being finalized and will ensure that all those working with these funds have a deep understanding of why Work Based Learning is being used as a strategy to engage both businesses and job seekers. Kevin indicated that the training is due to kick off on April 25, 2022 with a subsequent session on May 2, 2022. There will be a week break and then two more sessions will be held. This will ensure that all local areas are fully trained by the start of the new program year on July 1, 2022. Kevin reminded membership that training dollars were included in the OJT allocation sent to each local area by NJDOL. GSETA will be invoicing each local area for training costs and then will make payment to EDSI.

Kevin indicates that this training collaboration is a start of the expansion of the GSETA Institute being involved in broader training that also engage our partners. Constant Contact has been used to send out information on GSETA training opportunities. A system has been established to send the link to Monica Mulligan separately so that it can be distributed to GSETA membership without fear of the original notice via Constant Contact being sent to spam. Pat Leahey indicated that in 3 days they have had 78 people register for the "Dealing with Angry Clients" workshop coming up at the end of the month. She indicated that they will close the registrations when they hit 100, as the effectiveness of the workshop decreases when the participants goes above that number. If needed, they will schedule a second workshop. Pat further indicated that they would like to record these sessions but have had trouble with storage issues. Allisson Spinelli indicated that she has a

meeting scheduled to discuss storage issues and that it is hoped to have this resolved in short order. Diane Seavers recommended a YouTube channel where videos can be uploaded. Allison indicated that this will be explored.

Kevin provided a brief update on the MOU between GSETA and the NJ Consortium of County Colleges. He indicated that there will be a ceremonial signing of the MOU along with a press conference or press release that speaks to the collaboration between the two organizations and their efforts to work together on future projects together. There may be future funding or grant opportunities that GSETA and Consortium can explore together.

Kevin reminded the group that a NAWB annual conference is being held in person in Washington DC April 11th -April 14th. While there is still time to register, the early bird special for the room rate expires today. Kevin indicated that he and Diane Seavers will be there to represent GSETA and Middlesex County. He indicated the conference looks like it has a lot of informative workshops and sessions. The full agenda is on NAWB's website.

Kevin updated membership on the status of GSETA finding a part time executive director. He indicated that in discussions with the Executive Committee, the job description is being developed using a template from a North Carolina organization like GSETA. A It is envisioned that this will be a 15 hour per week position paying between \$40.00 - \$50.00 per hour for a total of a \$30,000.00 - \$40,000.00 investment. Kevin indicated that GSETA is financially sound and can support this position. The timeline is to post the position in April to have time to interview candidates and plan on hiring to coincide with the start of the new program year, July 1st. The executive director would help manage some of the projects that GSETA is involved in and would take some of the pressure of those that serve on the Executive Committee as well as those that serve on GSETA subcommittees. Deliverables include day to day operations, financial oversight in collaboration with Leslie Williams, conference planning support in collaboration with Allison Spinelli, Pat Leahey and Pat Fenn, and seeking out and managing grants. Both Virgen Velez and Davi Alpart voiced support for this plan, indicating that this has been discussed over the years and this seems like this is a good time for GSETA to re-group and be creative with finding ways to support the work of the organization.

Regional and State Plans

Kevin Kurdziel informed membership that he has spoken with Gary Altman from the SETC who let him know that they have not yet established a timeline for local and state plans. The state is currently in the process of completing their plan, it still must go out to stakeholders for comment, and then it must be posted for a 30 day public comment period. Gary indicated that once the timeline is established, it will allow regional and local areas 6 months to complete the planning process.

UI Return to the One Stops

Kevin Kurdziel indicated that Ron Marino from UI will be meeting with WDB Directors on March 17th ahead of the March 28th return of UI services to local One Stops. If anyone that will not be at that meeting have specific questions that they would like asked, please let Kevin know. There was robust discussion about the return of UI, with little to no information coming to the local areas from the state. Howard Weiss indicated that the state issued a press release of on-site services but have not given any information to the public on how claimants can access these services, as it has been heard that walkins will not be allowed and everyone must have an appointment. Local areas are not even clear on the process. It was made clear that not all the local areas even know who will be offering in-person UI services, as no list came out from the state. Fran Kuhn indicated that he has a map of where services will be located. He will send it to Monica Mulligan to distribute to membership (attached). There were major concerns about on-site security and how UI claimants will react when they try to walk in to get services. Jeff Swarts reports that Camden County has experienced an escalation of aggressive behavior in IU claimants that are approaching County workers in parking lots trying to get answers about their claims. Karen Gaylord expressed concerns about long lines outside of the building and how that intersects with security and orderly process. Paul Grzella indicated that he is working on signs to be posted outside of local offices indicating that in-person IU services are not being offered at this location. Many local areas indicated that the IU phones have been removed from their offices and they no longer have direct access to UI through that mode of communication. There has not been clear messaging from the state on what process should be followed to access on-site services. Kevin indicated that GSETA will do a press release that contains more specific information on the process and will work with Paul Grzella to get that out. There was suggestion and agreement that messaging should not go out until the information on process is confirmed as to not add to confusion.

Strategic Planning Committee

Kevin spoke briefly about the strategic planning process for GSETA. He indicated that starting on this project is being put on hold so that an in-person kick off can be planned for late May/early June. This timeline would also work better with the hiring of an executive director who would be able to help support the strategic planning process.

Committee Updates:

Monitoring Committee – Yolanda Taylor reported that the next meeting is scheduled for April 21, 2022.

MIS Committee – Diane Seavers indicated that the February meeting has a Q/A session with Sarah-Singer Quast's team and that there were some general questions about AOSOS data entry. The meeting was recorded if anyone would like to listen in. The next meeting of this committee is scheduled for March 30, 2022 at 10:00AM.

Operations Committee - Fran Kuhn reported that the committee met on March 7, 2022. At that meeting, WFNJ mandatory roll-out was discussed. Each area handles programming and process differently. The state has not provided information they on what would be considered an excused absence though they have indicated sanctions are being imposed at this time. Work Based Learning was briefly discussed as were customer satisfaction surveys. There was an ask at the meeting about new training opportunities in new career pathways, but none had been identified. If anyone knows of training opportunities in new career paths, please let Fran know. The next meeting is scheduled for April 4, 2022 at 10AM.

Youth Committee: Kendra Lee reported that the committee will meet again on April 4, 2022 at 3PM. Kendra indicated that local areas should have received their Summer Youth Employment Program (SYEP) today. It was indicated that funds were both WIOA Youth and WFNJ for SYEP. The NGO indicated the only requirement for program participation was in and out of school youth.

Fiscal Committee: Allison Spinelli reported that the next meeting will be held on March 21, 2022 at 10AM.

Allison also reminded membership that they are seeking a Co-Chair for the Conference Committee.

Open Discussion

There was no additional information or updates shared.

Adjournment:

Jeff Swarts made the motion to adjourn the meeting. Larry Sternbach seconded it. There were no objections or abstentions. The motion was approved. The meeting was adjourned at 11:22AM.

The next GSETA meeting is scheduled for April 13, 2022 at 10:00AM via Zoom.
